Appendix 1: Agenda Item 8: Proposed Amendment to Club Rule Sec. 2(8) (Members Conduct)

The committee has reviewed Club Rule Section 2 (8a) (Members Conduct) in line with the Club's Safeguarding Policy and Guidance and advise that the current process fails to protect the confidentiality of Members including vulnerable adults and children. This proposal to amend Club rule 8 ensures confidentiality in the process, protects vulnerable adults and children and aligns with RYA recommendations.

Section 2(8) Members Conduct

8a Conduct of Members

Every member upon joining the Club and thereafter, is deemed to have notice of, and undertakes to comply with the Club Rules and any Bye-laws and Regulations of the Club. Any breach of compliance or any conduct which, in the opinion of the Committee, is either unworthy of a Member or otherwise injurious to the interests of the Club, shall render a Member liable to disciplinary action by the Committee, which may include suspension for a specified period or expulsion.

Before taking such disciplinary action against a Member, the Committee shall give the Member full opportunity of making explanation to the Committee (either in writing or in person) or to the Welfare officer in the case of safeguarding concerns, or of resigning.

A resolution to apply any sanction shall be carried by a simple majority vote by those Members of the Committee present and voting on the Resolution.

Appeal against suspension or expulsion may be made to a panel of 3 members not involved in the Committee's decision. This appeal panel shall be comprised of any Club Trustees not on the Committee and, if necessary, other Members of long-standing continuous membership of not less than 10 years.


Upon suspension or expulsion, the Member/former Member shall not be entitled to have any part of the annual Membership fee refunded and must return any Club keys, trophies or other Club property held forthwith.

Upon expulsion of a Member, the Member will be given at least one month to remove all boats and other property from the Club premises. After one month the Committee may dispose of the former Members property in accordance with rule 11f(ii).

8b Vulnerable Adult and Child Protection

Any Member who is involved with supervision or teaching of Vulnerable Adults or Children must be in possession of a clear basic DBS check. Committee Members should also have a clear basic DBS check. The basic DBS check should be renewed every 3 years.

The Committee may at its discretion request a basic DBS check on any Member.
