# HARLOW BLACKWATER SAILING CLUB RULES 2023

NOTE: HEADINGS AND SUB HEADINGS ARE PROVIDED FOR CONVENIENCE ONLY AND SHALL NOT AFFECT THE CONSTRUCTION OF THESE RULES.

#### **SECTION 1: NAME AND OBJECTS**

RULE NO.

# 1. Name:

The name of The Club shall be "THE HARLOW (BLACKWATER) SAILING CLUB" (hereinafter referred to in these Rules as "The Club.")

#### 2. Objects:

The object for which The Club is formed are to promote and facilitate community participation in sailing, and also to provide such social and other facilities for members as may from time to time be determined necessary to achieve this object.

The Club is a non-profit making organisation. All profits and surpluses will be used to maintain or improve The Club's facilities. No profit or surplus will be distributed.

#### **SECTION 2: MEMBERSHIP**

3. Eligibility:

Any person who is interested in sailing is eligible as a candidate for membership

4. Categories of Membership:

There shall be the following categories of membership with power to vote at all meetings of the Club as indicated hereunder:

- 1 ORDINARY MEMBERS:
  - a. FULL SINGLE: being a person who, at the date of election, shall have attained the age of eighteen years shall have one vote.
  - b. FULL FAMILY: One adult or two adults living together and any of their children under the age of 18 or as may be prescribed by The Committee from time to time. The family unit shall have one vote per adult.
  - c. PROVISIONAL SINGLE/FAMILY: As above but for persons unable to fulfil the requirements for Rule 5 a. and shall have no vote. (This category of membership will be applied.). This membership will automatically be amended to full membership one year after you have joined the club. Subject to HBSC Committee approval.
  - d. STUDENT: One person age 18 or over in full time education and shall have one vote.
  - e. YOUTH: One person age 7 to 17 years inclusive, other than one whose membership is covered by Rule 4 (1) b. and shall have no vote.
    - This category of membership will only be accepted if a parent or guardian is a member, or an adult member of the club with the consent of the parent(s)/guardian accepts responsibility for supervising the youth whilst on the club premises or whilst involved in club sponsored activities. The committee may also at its discretion specify other restrictions it feels appropriate to safeguard both the youth and other club member's wellbeing.

# 2 HONORARY MEMBERS

The Club may on the recommendation of The Committee elect up to six honorary members provided that the total of such honorary members at any time shall not exceed 5% of the total number of Club members at that time. Election of honorary members shall be by a two-thirds majority of those present and voting, on a motion put by The Committee at a general meeting. The

Membership Secretary shall send to a person elected an honorary member written notice of election and a copy of these rules, and upon intimation of willingness to take up the membership, the person shall become an honorary member of The Club. Honorary members shall pay neither entrance fee nor subscription and have no vote.

#### 3 SENIOR MEMBERS

A current member who has been a continuously paid-up member for a minimum of 20 years and who has reached the age of 65, shall on the following 1<sup>st</sup> January, automatically become a Senior Member, paying a reduced subscription which shall be set at the discretion of The Committee. In the case of family membership, the reduced subscription will apply when either partner complies with the above conditions. A Senior Member shall have the rights and privileges of an ordinary member and have one vote. The Senior family unit shall have one vote per adult.

#### 4 AFFILIATES

Organisations interested in sailing may be accepted as affiliates at the discretion of The Committee and have no vote.

### 5. Election of Ordinary Members.

Membership of the Club shall be open to anyone interested in non-motorised watersports on application regardless of sex, age, disability, ethnicity, nationality, sexual orientation, religion or other beliefs. Membership may however be limited according to available facilities on a non-discriminatory basis. Non-sailing motorised cruisers (displacement hull craft) may be permitted at the discretion of the committee.

#### a. Application.

Application for membership shall be in a form prescribed from time to time by The Committee, and shall include the name and address of the candidate and such information as The Committee may prescribe from time to time.

#### b. Admission.

Persons may not be admitted to membership, or be admitted as candidates for membership, to any of the privileges of membership without an interval of at least two days between their nomination or application for membership, and their admission.

#### c. Election.

The election of all categories of members is vested in The Committee and shall be by a vote of a simple majority of those Committee members present and voting in a meeting conducted as prescribed in Rule 19. The Club Committee may refuse membership or, subject to Rule 8a, remove it, only for good cause such as conduct or character likely to bring the Club or sport into disrepute. Appeal against refusal of membership may be made to the members.

# d. Notice of Election.

The Membership Secretary shall immediately inform each candidate in writing of the candidates election or non-election and shall furnish an elected candidate with a copy of these Rules and The Club Bye Laws, and providing payment of the entrance fee and first subscription has been made in accordance with Rule 11 the candidate shall become an Ordinary Member of The Club.

# 6. Membership List.

The membership secretary shall keep a record of current members names and addresses in duplicate, one copy of which shall be kept in the bar, for general access, to members during bar opening times. Also members shall have the right to have their contact details omitted from the list kept in the bar.

# 7. Members Addresses.

Every member shall furnish an up to date address to the Membership Secretary who shall record this in the Membership List. Any notice sent to such address shall be deemed to have been delivered.

#### 8. Members Conduct.

#### a. Conduct of Members.

Every member upon joining the Club and thereafter, is deemed to have notice of, and undertakes to comply with the Club Rules and any Bye-laws and Regulations of the Club.

Any breach of compliance or any conduct which, in the opinion of the Committee, is either unworthy of a Member or otherwise injurious to the interests of the Club, shall render a Member liable to disciplinary action by the Committee, which may include suspension for a specified period or expulsion.

Before taking such disciplinary action against a Member, the Committee shall give the Member full opportunity of making explanation to the Committee (either in writing or in person) or to the Welfare officer in the case of safeguarding concerns, or of resigning.

A resolution to apply any sanction shall be carried by a simple majority vote by those Members of the Committee present and voting on the Resolution.

Appeal against suspension or expulsion may be made to a panel of 3 members not involved in the Committee's decision. This appeal panel shall be comprised of any Club Trustees not on the Committee and, if necessary, other Members of long-standing continuous membership of not less than 10 years.

Upon suspension or expulsion, the Member/former Member shall not be entitled to have any part of the annual Membership fee refunded and must return any Club keys, trophies or other Club property held forthwith.

Upon expulsion of a Member, the Member will be given at least one month to remove all boats and other property from the Club premises. After one month the Committee may dispse of the former Members property in accordance with rule 11f(ii).

#### b. Vulnerable Adult and Child Protection

Any Member who is involved with supervision or teaching of Vulnerable Adults or Children must be in possession of a clear basic DBS check. Committee Members should also have a clear basic DBS check. The basic DBS check should be renewed every 3 years

#### 9. Resignation of Members.

Any member resigning their membership shall notify the intention of doing so to the Membership Secretary in writing and shall be liable for the whole annual subscription for the year in which such resignation is notified, at the discretion of The Committee. All club keys must be returned.

#### 10. Visitors.

- a. Members may introduce visitors to The Club as guests, subject to restrictions and regulations, which The Committee may make and limited to four guests of any one member not more than three times in one year. The member introducing a guest or guests shall enter the guest's name in the visitors book and sign as having introduced the guest(s), and shall be responsible for the conduct of the guest(s).
- b. Visitors taking part in any regatta or sailing competition authorised by The Committee shall, subject to restrictions and regulations which The Committee shall make, be admitted to the facilities of The Club for the period of the said function.
- c. Visitors wishing to sail and use The Club's facilities may purchase a Visitor Sailing Ticket at a price fixed by The Committee. A maximum of four visits is permitted, weekends and bank holiday weekends to count as one visit each.

#### 11. Fees and Subscriptions.

Membership subscriptions will be kept at levels that will not pose a significant obstacle to people participating.

a. There shall be an Entrance Fee of a sum which shall be determined by The Committee from time to time and shall be payable on application for membership.

- b. An annual membership subscription of a sum, which shall be determined by The Committee from time to time shall be due and payable on application for membership and on the first day of January in each year thereafter. A late payment fee may be imposed.
- c. A member elected after the 31<sup>st</sup> of July in any one year shall pay a reduced subscription in that year, from the date of acceptance of the application by the committee. The reduced rates shall be determined by The Committee.
- d. The Committee has the power to reduce the subscriptions of individual existing members.
- e. Any member whose annual subscription and any other annual fees have not been paid by the first day of April shall be requested in the name of The Committee to pay the amount outstanding by 15<sup>th</sup> April and if the said amount is not paid by the 15<sup>th</sup> May, the members name(s) shall be removed from the Register of Members and the Membership Secretary shall advise the member in writing that their membership has ceased. Any such member may be re-elected at the discretion of The Committee after payment of all arrears.
- f. If at any time any fee for parking, storing or mooring any yacht, dinghy or tender payable to The Club by any member or former member shall fall three months or more in arrears The Committee may:
  - i. Cause such vessel to be moved without being liable for any loss or damage to the vessel however caused.
  - ii. Give one month's notice in writing to the member or former member at their last address shown in the register of members and thereafter sell the vessel and deduct any money due to The Club (whether by way of arrears or subscriptions or any other payments) from the net proceeds of sale before accounting the balance (if any) to the member or former member. Alternatively any vessel which in the opinion of The Club cannot be sold may, upon such notice as aforesaid, be disposed of in any manner that The Committee may think fit and the costs of so doing and any arrears as aforesaid to be a debt owing to The Club by the member or former member PROVIDED ALWAYS THAT:-Proper evidence is available to show that all reasonable steps have been taken to trace a member or former member and that when and if the vessel is sold the proceeds of sale (less any indebtedness by the member or former member to The Club) shall be placed upon bank deposit account and retained against the eventuality of a claim by the owner (whether he be the said member or former member or otherwise) for a period of six years.

# 12. Damage to Club Property.

A member shall not knowingly remove injure, destroy or damage any property of The Club and shall make restitution for the same if called upon to do so by The Committee or by the Honorary Secretary upon the instructions of The Committee.

#### 13. Access.

The Club's grounds, premises and facilities except the bar, galley and inner club house and such areas and facilities as may be proscribed in the Bye-laws shall be accessible to members at all times subject to provisions for security.

# 14. Limitation of Club Liability.

Members their guests and visitors are bound by the following Rule which shall also be exhibited in a prominent place within The Club premises:-

Members of The Club, their guests or visitors may use The Club premises, and any other facilities of The Club, entirely at their own risk and impliedly accept:

- a. The Club will not accept any liability for any damage to or loss of property belonging to members their guest or visitors to The Club.
- b. The Club will not accept any liability for personal injury arising out of the use of The Club premises, and any other facilities of The Club either sustained by members, their guests or visitors or caused by the said members, guests or visitors whether or not such damage or injury could have been attributed to or was occasioned by the neglect default or negligence of any of them, the Officers, Committee or servants of The Club.

#### **SECTION 3: MANAGEMENT**

# 15. Management of Club by Committee.

The affairs of The Club except those specifically dealt with in general meeting shall be managed by an elected executive committee referred to in these Rules as "The Committee".

The Committee shall manage the affairs of the Club according to the Rules and shall cause the funds of the Club to be applied solely to the purposes of the Club or for a benevolent or charitable purpose nominated by General Meeting.

In particular the Committee shall ensure that the property and funds of the Club will not be used for the direct or indirect private benefit of members other than as reasonably allowed by the Rules and that all surplus income or profits are re-invested in the Club.

#### 16. Constitution of The Committee.

The Committee shall consist of fifteen members elected in accordance with Rule 17 and who shall be known collectively as Committee Members. Twelve of these Committee Members shall be elected to the following specific positions and shall also be known as Officers of The Club:-

Commodore

Vice Commodore

**Honorary Secretary** 

Honorary Treasurer

**Cruiser Secretary** 

Sailing Secretary

Watersports Secretary

**House Secretary** 

Membership Secretary

Hospitality Secretary

**Publicity Officer** 

Social Secretary

The Commodore and Vice Commodore shall also be known as Flag Officers.

Any Officer may temporarily take over the duties of another Officer at the discretion of The Committee

#### 17. Election of Committee:

#### a. Election.

Elections of Committee Members shall be held at the Annual General Meeting.

#### b. Eligibility for Election.

All members who are entitled to vote at a general meeting and who have been members for one year or more, shall have equal rights to be nominated for election to The Committee, and shall have equal rights to nominate eligible members for election.

#### c. Nomination.

No candidate for election to The Committee other than the retiring Committee members shall be proposed unless the name of such candidate, their proposer and seconder shall have been sent to the Honorary Secretary at least thirteen days before the Annual General Meeting. In the event of insufficient candidates having been nominated, nominations may be accepted at the Annual General Meeting. Each nomination for an officer shall be one of the named positions on The Committee and shall state the title of the office for which the candidate is proposed.

#### d. Ballot.

- i. Election shall be by ballot if the number of nominations for any position of officer is two or greater, or if the number of candidates for Committee Members other than officers exceeds number of vacancies to be filled.
- ii. If the number of nominations for Committee Members other than officers is equal to or less than the number of vacancies to be filled or if there is a single nomination for any particular post of officer then all such candidates shall be deemed to be elected if a majority of those Club members present at the Annual General Meeting, and entitled to vote, vote in favour of such an election.

#### e. Terms of Office.

Election to a Committee shall be for a term of office of not less than one year or until conclusion of the next Annual General Meeting whichever is later.

#### f. Re-election.

Any Committee Member shall be eligible for re-election except that no Flag Officer shall serve more than three consecutive years in one office.

# g. Casual Vacancy.

If for any reason a vacancy shall occur on The Committee during its term of office The Committee may co-opt an Ordinary Member to The Committee until the next Annual General Meeting. A member so appointed may stand for re-election on expiry of the term.

#### 18. Retirement from Committee.

A Committee Member shall be deemed to have resigned their position upon The Committee's acceptance of their letter of resignation to the Honorary Secretary or their death or failing to attend three consecutive Committee Meetings without written explanation.

#### 19. Committee Procedure.

# a. Meetings.

The Committee shall meet at least every two months, making such arrangements as to place of assembly as it may wish. Meetings may be held remotely by video calling and Committee members may access in-person committee meetings remotely by video calling.

#### b. Chairman.

The Commodore shall preside as chairperson at each meeting or in their absence the highest ranking flag officer present will preside. In the absence of all flag officers, a chairman for a meeting shall be elected by those present.

## c. Quorum.

The quorum for all committees/sub-committees shall be 50% plus one of a registered committee, this shall constitute a quorum for any Committee Meeting.

#### d. Voting.

Voting at a Committee Meeting (except in the case of a resolution relating to the expulsion of a member) shall be by a show of hands. A motion shall be carried by a simple majority.

#### 20. Committee Powers, Duties and Limitations.

- a. The Committee shall manage the affairs of The Club according to these Rules and shall cause the funds of The Club to be applied solely to the objects of The Club.
- b. The Committee shall make such Bye-laws and Regulations as it shall from time to time consider to be necessary and shall cause the same to be exhibited in the Clubhouse for fourteen days before the date of implementation. Such Bye-laws and regulations shall remain in force until set aside by The Committee.

#### c. Sub-Committees.

The Committee shall appoint a Bar Sub-committee of three persons and may appoint such other sub-committees as it may deem necessary, and may delegate to a sub-committee such of its powers as it may think fit upon such terms and conditions as shall be deemed necessary and/or required by the law. Such sub-committees shall consist of not less than three persons who shall be members of The Committee and co-opted Club members. Not less than one Committee member shall be on each sub-committee, except in the case of the Bar sub-committee, which shall consist only of elected Committee members. Resignation of office on The Committee shall also involve resignation of office on any sub-committee. Flag Officers shall be ex-officio members of all sub-committees. Minutes of meetings shall be taken by the Chairman of each sub-committee.

#### d. Contracts.

The Committee or any person authorized to transact business for The Club shall disclose to third parties that he is so acting, and shall enter into contracts only so far as expressly authorized (or authorized by implication) by The Committee. No one shall, without the express authority of the membership in General Meeting, pledge the credit of the membership.

The Committee shall endeavour to ensure that the following clause is incorporated in every contract, lease, licence or other agreement entered into by the Committee and/or Trustees of the Club, as appropriate.

"The liability of the Committee/Trustees for the performance of any contractual or other obligation undertaken by them on behalf of the Club shall be limited to the assets of the Club."

#### e. Members Indemnification of Committee.

In pursuance of the authority vested in The Committee by members of The Club, members of The Committee are entitled to be indemnified by the members of The Club against any liabilities properly incurred by them or any one of them on behalf of The Club wherever the contract is of a duly authorized nature or could be assumed to be of a duly authorized nature and entered into on behalf of The Club. Should the assets of the Club be insufficient to satisfy such liability, costs, expenses or payments the Committee members shall be entitled to a personal indemnity from the individual members of the Club. The limit of an individual member's indemnity in this respect shall be a sum equal to one years subscription at the current rate for that category of membership unless The Committee has been authorized to exceed.

# **SECTION 4: DUTIES OF SECRETARY Etc.**

# 21. The Honorary Secretary shall:-

- a. Ensure that a register is kept of Club members' names and addresses.
- b. Conduct the correspondence of The Club.
- c. Keep custody of all Club documents.
- d. Keep full minutes of all meetings of The Club and The Committee, which shall be confirmed and signed by the appropriate Chairman upon the agreement of The Club or The Committee at the next following meeting of The Club or The Committee.
- e. Maintain contact with The Club's Legal Advisers to ensure that The Club's affairs are managed in accordance with current law

#### 22. The Honorary Treasurer shall:-

- a. Cause such books of account to be kept as are necessary to give a true and fair view of the state of the finances of The Club.
- b. Cause all returns as may be required by law in relation to such accounts to be rendered at the due time.

- c. See to the maintenance of such insurance policy or policies as may be needed fully to protect the interests of The Club and its members.
- d. Prepare an Annual Balance Sheet as at the 31st December in each year and cause such Balance Sheet (and accounts as necessary) to be audited at least once annually and shall thereafter cause the same to be exhibited in The Club premises at least fourteen days before the date of the Annual General Meeting.

# 23. The Honorary Auditor shall:-

- a. Be appointed at the Annual General Meeting in each year.
- b. Audit the accounts of The Club when called upon to do so and shall give such certificate of assurance as to the accuracy of the said accounts as shall be required by law or by The Committee.
- c. If unwilling or unable to act, inform The Committee who shall appoint a substitute to hold office until the termination of the next Annual General Meeting.

# SECTION 5; PURCHASE AND SUPPLY OF EXCISABLE GOODS.

- 24. a. The purchase for The Club and the supply on Club premises of excisable goods shall be exclusively and solely under the control of The Committee or of a sub-committee appointed solely for this purpose by The Committee.
  - b. Intoxicating liquor may only be sold on Club premises to persons who are entitled to use The Club premises in accordance with Rules, Bye Laws and regulations for the time, being in force, with the exception that no intoxicating liquor shall be supplied to a person under the age of eighteen, neither may any person under the age of eighteen purchase, attempt to purchase or consume intoxicating liquor on the premises, Cigarettes, tobacco or other products containing tobacco, will not be sold on the club premises.
  - c. No intoxicating liquor shall be supplied by or on behalf of The Club for consumption off the premises except to a member in person.
  - d. Club Bar. The opening times of The Club bar for the sale of intoxicating liquor shall be decided by The Committee in accordance with the requirements of the Licensing Authorities and by law. The Committee shall cause the Club bar to be opened (subject to terms of the Club premises certificate) at convenient times. Such opening times shall be stated in The Club Bye Laws and shall be prominently displayed in The Club premises for the sale of excisable goods to persons who are entitled to the use of the premises of the Club in pursuance of these Rules (except Youth Members as aforesaid) PROVIDED THAT visitors' names and addresses and the name of their introducer shall have been entered in the Visitor's Book upon entry to Club premises. Any alteration to the opening times shall not be effective until such times as notification has been given to the Court.
  - e. No arrangement is to be made which restricts The Club's freedom of purchase of intoxicating liquor.
  - f. No person shall take a commission, percentage or other such payment in connection with the purchase of excisable goods for the Club. Any profit deriving from the supply of such goods shall (after deduction of the costs of providing such goods for the benefit of the Club) be applied to the provision of additional amenities or the purchase of property to be held in trust for the benefit of the Club.
  - g. Proper accounts of all purchases and receipts shall be kept and presented at the Annual General Meeting in each year and such information as the Secretary or Reviewers may require shall be furnished to enable statutory return or statement and the payment of excise or other duty or tax to be made.

# **SECTION 6; TRUSTEES**

- 25 a. There shall be at least three Trustees of the Club who shall be appointed from time to time as necessary by the Committee of the Club from among Full, Family or Honorary Members who are willing to be so appointed.
  - A Trustee shall hold office for a maximum term of 25 years, or until they shall resign by notice in writing given to the Committee or until a resolution removing him/her from office shall be passed at a meeting of the Committee by a majority comprising two-thirds of the members present and entitled to vote.
  - b. All the property of the Club, including land and investments, shall be held by the Trustees for the time being, in their own names so far as it is necessary and practicable, on trust for the use and benefit of the Club. In the event of the death, resignation, or removal from office of a Trustee, the Committee shall nominate a new Trustee in his place, and shall as soon as possible thereafter take all lawful and practicable steps to procure the vesting of all Club property into the names of the Trustees as constituted after such nomination. For the purpose of giving effect to any such nomination, the Secretary for the time being is hereby nominated as the person to appoint new Trustees of the Club within the meaning of Section 36 of the Trustee Act 1925 and he shall by Deed duly appoint the person or persons so nominated by the Committee.
  - c. The Trustees shall in all respects act, in regard to any property of the Club held by them, in accordance with the directions of the Committee and shall have power to sell, lease, mortgage or pledge any Club property so held for the purpose of raising or borrowing money for the benefit of the Club in compliance with the Committee's directions (which shall be duly recorded in the Minutes of the proceedings of the Committee) but no purchaser, lessee or mortgagee shall be concerned to enquire whether any such direction has been given. The total value of mortgages or other loans shall not exceed 50% of the value of Club property without approval of two-thirds majority of those present and voting, on a motion put by The Committee at a general meeting.
  - d. In pursuance of the authority vested in the Trustees by the members of the Club, the Trustees shall be indemnified by the members of the Club out of the assets of the Club from and against any liability, costs, expenses or payments whatsoever which may be properly incurred or made by them or any one of them in the exercise of their duties or relation to any property of the Club vested in them, or in relation to any legal proceedings, or which otherwise relate directly or indirectly to the performance of the functions of a Trustee of the Club.

Should the assets of the Club be insufficient to satisfy such liability, costs, expenses or payments the Trustees shall be entitled to a personal indemnity from the individual members of the Club. The limit of any individual member's indemnity in this respect shall be a sum equal to one year's subscription at the then current rate of that category of membership unless the Trustees have been authorised to exceed such limit by a General Meeting of the Club.

# **SECTION 7; GENERAL MEETINGS**

26. a. A.G.M.

An Annual General Meeting of The Club shall be held each year on a date to be fixed by The Committee, and no more than fifteen months shall elapse between such meetings. The Honorary Secretary shall at least twenty-one days before an Annual General Meeting post or deliver to each Member of The Club notice thereof and of the business to be put to the meeting.

b. Business at A.G.M.

The business of the Annual General Meeting shall be: -

- i. To pass the Treasurer's report and Accounts for the previous year.
- ii. To pass the Annual Report of The Committee on the state of The Club's property and activities.

- iii. To transact any business stated in the notice of the meeting.
- iv. To elect Committee members, Trustees, Auditors and Honorary members.
- v. Any other business given to the Honorary Secretary in writing or e-mail by a member entitled to vote at least fourteen days before the date of the AGM.
- c. General Meetings called by The Committee.

The Committee may on giving fourteen days notice, call a General Meeting of The Club for any specific business, the nature of which shall state in the summons convening the meeting and the discussion at such meetings shall be confined to that business only.

d. General Meetings called by Members.

The Committee shall also call a General Meeting on the written request of at least six members within twenty-eight days of the receipt of such request.

e. Chairman.

At each General Meeting of The Club the Chairman shall be the Commodore or in his or her absence a Chairman elected by those present.

f. Voting Rights.

At any General Meeting including the Annual General Meeting all members entitled to use The Club's premises and facilities shall be entitled to vote and each member including two partners in a family membership shall have equal voting rights, but no voting rights shall be given to Honorary members and members under eighteen years of age. Voting shall be confined to members.

g. Voting.

Except where otherwise prescribed by these Rules voting at any General Meeting shall be by a simple majority vote on a show of hands.

h. Chairman's Vote.

The Chairman may cast his or her vote after a ballot has been counted provided he or she has not already voted in that ballot.

i. Quorum.

Twenty-five members entitled to vote and present shall form a quorum at any General Meeting of The Club.

j. Rule Change.

The creation, repeal or amendment of a Rule shall only be passed by a majority vote of at least two-thirds of those present and entitled to vote on a resolution properly put to a General Meeting of The Club. Provided that no such change shall jeopardise the Club's status as a Community Amateur Sports Club within the meaning of the Finance Acts, or in any event alter its purposes or winding-up provisions.

#### **SECTION 8: DISSOLUTION.**

- 27. If, upon winding up or dissolution of The Club, there remains after the satisfaction of all its debts and liabilities any assets whatsoever, the same shall not be paid to or distributed amongst the members of The Club. The Committee shall dispose of the net assets remaining to one or more of the following:
  - (i) to a sailing charity and/or
  - (ii) to another Club with similar sports purposes which is a registered CASC and/or
  - (iii) to the sport's national governing body for use by it for related community sports.

# Harlow (Blackwater) Sailing Club Byelaws

#### General

- 1. All boats on club premises must be adequately insured against third party risks.
- 2. HBSC will not accept liability for any claim against a member.
- 3. No power boats are admitted to the club.
- 4. All Cruiser, Dinghies, Tenders, Trailers & Trolleys must carry the current years payment sticker.
- 5. Cars should be parked in the car park only. Speed on access road is limited to 5 mph.
- 6. Members may bring visitors up to three times per visitor per year. After this they are expected to apply for membership.
- 7. Children are welcome, but parents must arrange supervision whilst out sailing.
- 8. Children must be kept clear of the jetty and main runway when boats are being launched or recovered. Children must wear Buoyancy aids when on the jetty and when on the water.
- 9. The wearing of buoyancy aids for all members is advisable when on the jetty or on the water.
- 10. Portable radios are not permitted to be used in the clubhouse or grounds.
- 11. Members are expected to maintain the general tidiness of the clubhouse and grounds. Any property left for long periods on the Club premises may be disposed of by the committee.
- 12. Dogs must always be kept on a lead and not allowed to foul anywhere on the Club premises. They are not allowed in the clubhouse or changing rooms.
- 13. Smoking is not permitted in any of the club buildings.

# **Dinghies and Sailboards**

- 13. The classes of sailing dinghy are subject to the approval of the Committee. As of 1<sup>st</sup> July 2012 all further catamarans will need to be approved by the Committee.
- 14. Dinghies must be securely tied to the points provided by rope of adequate strength to withstand high winds.
- 15. Trolleys and trailers may only be left in the member's allocated space in the dinghy park.
- 16. Personal buoyancy must be worn while racing. Wet suits or dry suits must always be worn during the winter and spring series.
- 17. Visitors who wish to launch a dinghy must purchase a Day Sailing Ticket and comply with its requirements
- 18. Dinghy Sailors proposing to take part in a club race should not take their dinghies down the jetty until the club support boat has been launched or unless instructed to do so by the officer of the day. Failure to comply with this byelaw could result in disqualification from any events sailed on that day.
- 19. No junior members under 14 years of age may crew /helm or be a passenger on a club safety boat whilst it is actively engaged in or rostered to carry out rescue duties at any time.
- 20. On the dates published in the club programme as Cruiser Launch or Recovery days, no other club activities must take place that require the use and/or the ramp areas. On any other day cruiser launching will have no priority, but for safety, cruiser launching and other activities must be scheduled by agreement between the club officers or persons in charge of the activities.
- 21. Club boats are primarily for training and club organised activities, permission should be sought from a club officer before use and this use is restricted to the area of water within sight of the jetty or under support boat cover if racing.

#### **Cruisers**

- 22. Member's allocated moorings are responsible for maintenance and where necessary, re-laying of the ground tackle at their own expense. All moorings must comply with the club specification.
- 23. Moorings not taken by July 1st may be re-let at the discretion of the Committee.
- 24. Cruisers, trailers and launching trolleys may only be parked on the designated hard-standing areas, not on the concrete roads or in the car park. All of these must be clearly marked.
- 25. Parking positions for the above must be agreed with the cruiser secretary or the person supervising launching or haul-out. They may subsequently be moved by Club officials as necessary, so must be left in a movable state.
- 26. Tenders should be stored on the racks provided wherever possible. They must be marked with the cruiser's name and carry the current years payment sticker.
- 27. The maximum weight of cruiser allowed on the jetty is 3 tons, including trolley or trailer. This weight limit may be reduced if the jetty structure is deemed to be unsound by the committee. (*In the event of this action notice of the change will be given by letter to every cruiser member*).
- 28. Cruisers may only be launched or recovered using the Club winch equipment. The use of road vehicles for this purpose is not allowed. Vehicles may be allowed onto the jetty for a specific purpose with the agreement of the committee.

#### **Caravans and Tents**

- 29. Caravans and tents may only be parked in the Club grounds whilst the owners are sleeping in them at night or have gone sailing from the Club. Caravans may park for a maximum of 21 consecutive nights, with a 5 day break before a further period. A maximum of 100 nights per year is allowed.
- 30. Caravans may be parked on the area of grass by the sea wall or in summer on the cruiser hard-standing area. They must not be left in the car park.
- 31. All Caravans when on the club grounds must display clearly the membership number of the club member (either on the front window or by the hitching bracket.
- 32. A donation of £5 per night is suggested as a site fee and for use of club facilities.
